## Rules and Guidelines

The applicant understands and agrees to the following rules and guidelines.

1. The Columbarium is owned by Faith Presbyterian Church.
2. The applicant is reserving for perpetuity the use of the niche identified in the application.
3. The following items are included in the cost of the niche:
  - 1) Niche reservation for perpetuity.
  - 2) Engraving cost for the name, Date of Birth and Date of Death for each of the two persons who will be in the niche. The addition of the military branch(s) the person(s) served in is an additional cost that will be determined based upon the actual cost at the time of engraving. No other engraving is permitted.
  - 3) Opening and closing of the niche.
  - 4) Record-keeping by Faith Presbyterian Church.
  - 5) Future maintenance.
4. The niche size is 12" high X 12" wide X 16" deep.
5. The purchase of an Urn is NOT included.
6. The urn shall be used only for the inurnment of ashes.
7. No trinkets, medals, or valuables of any kind shall be placed in the urn or niche.
8. A pet's ashes may be mixed with human cremains but may not be included separately.
9. The ashes of two people may be co-mingled in a single urn.
10. Ashes may be removed from the columbarium for any reason by the personal representative or immediate family member of the person whose cremains have been inurned. However, in this case there will not be any reimbursement for the niche.
11. If the applicant moves their membership from Faith there are three options available for their reservation of the niche.
  - 1) Request the Cemetery Committee try to sell their membership to another Faith Presbyterian Church member at the price they paid.
  - 2) Pay the difference between the price they paid and the non-member price at the time of purchase and keep the niche.
  - 3) If requested by the applicant, the church may, at its discretion, repurchase the niche for \$350.00.
